FROM THE EXECUTIVE DIRECTOR

LEADERSHIP CHANGES: The recent death of Henry Pohlman, Founding Donor and Board Member, has been hard for us to accept. His optimistic leadership will always be remembered.

We also want to express our sincere THANKS to retiring Founding Donors, Nancy Holland, Thurlene Ruggels, and Tonya Murphy for their dedication and many years of serving on our board. The four new members to our 12-member board are Kenneth Cole, Frank Schulte, Mike Murphy, and Vance Ruggels. After serving as our board chairman for several years, Dennis Davidson recommended and it was adopted by the Board, that he become the immediate-past chairperson and Rev. Roger Dennis be our new Board Chairperson.

GRANTS AND SCHOLARSHIPS: Our Foundation is becoming a significant force in enhancing the quality of life for our communities. Our Governing Board awarded 14 grants totaling \$8,300 to local non-profit applicants and 31 scholarships to high school graduating seniors and students presently attending college, for a grand total of \$25,650. Without the support of our donors, this would not be possible. THANKS!!

TEACHER GRANTS: The “Apple Seed Program”, a Russell schools’ endowment, was started in July, 2008 and has received gifts from 97 new donors totaling \$19,370. The Kansas Health Foundation is providing a 50% match bringing the total to \$29,055. In the near future, we will be able to provide grants to support programs that will be a great benefit to our teachers.

THE NEW YOUTH ACTIVITY FUND: The mission is to change the lives of Russell youth by promoting involvement in extracurricular activities at a young age. It will focus on providing funds for athletic, fine arts, and community activities for youth who would otherwise not be able to financially afford to participate.
